## Product Description

Metamark CF3 is a calendered PVC giving a realistic simulation of Carbon Fibre. It may be used on flat or simple curves so is ideal for large flat vehicle panels, such as bonnets and roofs. The 150 micron film has a textured, embossed 3D finish matching closely Metamark CF4, but at a more affordable cost. It is durable for up to 5 years exterior use.

## Typical Applications

- CF3 is suitable for computer cut graphics and vehicle applications onto flat or simple curves.
- It is not suitable for conforming to complex curves.

## Application

- The product may be applied with a wet or dry application.
- Due to the embossing of the film, it is more sensitive to tearing along the embossing, so care is needed when handling.

## Maintenance

- Do not use car polishes on the product.
- Clean with warm soapy water.
